The artist will be included in all advertising done for and by the RRST group and the artist will be given a quantity of brochures to be used for their own advertising.
 - b) **\$100 per Guest Artist:** this fee provides a listing on the web site and brochure under the host artist (includes artist name, medium and description, phone, email and website) (*No art photograph*)

Additional Information about the 2007 Rural Routes Studio Tour

- All members, full or guest, must be juried in. Once juried in they can change from guest to full artist without further jurying.
- Members can be at someone else's space and still be a full artist, but a guest artist must be with a full member.
- Christmas in the Country is considered a full artist. They may include as many people as they wish, but they get one photo on the brochure and must all share space on the brochure and website as one artist.
- A full membership can be split, but again the brochure photo space would be shared, as well as the bio space on the brochure and website.
- Everyone is responsible for their own insurance coverage.
- RRST is not a charitable organization and we can not issue receipts for taxes. However any businesses that advertise with us can use the cost as a business expense.
- RRST is committed to donating 5% of all sales made on the weekend of the studio tour to a children's charity chosen by the group at the beginning of each year.
- Any exhibition, festival or other event that RRST is invited to participate in must be open to all our members. Any cost incurred at these events will be split by the participating artists. There is a banner and sign available for our use.
- All members are required to provide assistance with the tour organization and the distribution of brochures.
